4. Cut-off Date: Wednesday, 11th September, 2019.

Any person, who acquires shares of the Company and has become a member of the Company after dispatch of notice and holding shares as of the cut-off date i.e. 11th September, 2019 may obtain the login ID and password by sending an e-mail to evoting@nsdl.co.in by mentioning his Folio No. / DP ID and Client ID No. However, if any Member is already registered with NSDL for remote e-voting, then he can use his existing User ID and password for casting his vote. 6. E-voting by electronic mode shall not be allowed beyond 5.00 p.m. on Tuesday, 17th September, 2019.

7. The facility for voting through ballot paper shall be made available at the AGM and the members attending the meeting who have not cast their vote by remote e-voting shall be able to exercise their right at the meeting through ballot paper.
8. The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.
9. Members of the Company holding shares either in physical form or in dematerialized form as on the cut-off date of 11th September, 2019 only shall be entitled to avail the facility of remote e-voting as well as voting at the Annual General Meeting.
